



HPC Leadership Competency Training Course

(in January 2026)

Application Guidelines

The HPC Leadership Competency Training Course invites applications from individuals who aspire to enhance their leadership competencies and advance their professional careers in international organizations. This five-day training course, held in Hiroshima, Japan, is designed to strengthen participants' knowledge and skills in leadership, communication, negotiation, and management within the context of international organizations.

1. Duration

January 19 (Mon.) – 23 (Fri.), 2026

2. Program Structure

The course focuses on leadership and related competencies such as communication, negotiation, and management. The entire program will be conducted in English.

3. Venue

A designated hotel in Hiroshima, Japan.

4. Accommodation

Accommodation will be arranged at the course venue hotel in Hiroshima for six nights, starting from January 18, 2026.

5. Participation Fees

USD 2,000 (includes six nights of accommodation)

or

USD 3,000 (includes six nights of accommodation and round-trip flights between the participant's place of residence and Hiroshima, Japan)

<Those who have difficulty in participating in person due to visa restrictions, etc., we consider online participation. In such a case the fee is USD 1,500 for the entire program; and USD 1,000 for plenary sessions only.>

6. Qualifications

Applicants should:

Have a strong intention to pursue or advance a career in international organizations or other professional bodies. Experience in fields such as peace and security, development, or humanitarian aid is preferred.

Be fluent in spoken and written English.

Be available to attend the course in its entirety.

7. Number of Participants to be Admitted

Approximately 15 participants (but this number is not strictly fixed). There are no nationality restrictions.

8. Required Documents

(Applicants may substitute Sections 8–11 with the UN P11 form or an equivalent CV format.)

(Selection may be started before the deadline.)

11. Selection Process

Applications will be assessed based on two main criteria:

Experience and skills in relevant professional fields

Potential for future career advancement in international cooperation

Applicants will be notified of the selection results via email by the end of October 2025 at the latest, regardless of the outcome.
